1. By completing this application and submitting payment you acknowledge the terms and conditions of Ballarat YCW Harriers Inc. membership.
  2. This document relates to any person applying for membership with Ballarat YCW Harriers Inc. for the period 1/4/2024 to 31/3/2025. This registration is valid only for the nominated season and does not carry over into the next athletics year. Refunds will be determined at the discretion of the committee of Ballarat YCW Harriers Inc.
  3. I hereby make application for membership of Ballarat YCW Harriers Inc., and I agree to be bound by the Constitution, Rules, Regulations and Policies of the club, including but not limited to the Member Protection Policy & code of conduct.
  4. If the applicant is under 18 years-of-age, the parent/guardian is responsible for the applicant and the applicant's compliance to rules of membership.
  5.
